- All participants **MUST** be registered & checked in prior to fishing.
- Fish **MUST** be caught using a rod & reel from the banks of the pond.
- **NO ONE** is allowed in the water at any time. Nets are **NOT** allowed.
- Parents may **ASSIST** with casting but children **MUST** reel the fish in.
- NH State law relative to species restrictions and/or creel limits apply.
- Please bring all fish you will not keep to the measuring station ASAP so they may be released back into the water.
